RULES & REGULATIONS

- 1. **THE AIM:** To incubate interest, enhance friendship and to further develop basketball among Asian countries.
- 2. **PARTICIPATING TEAMS:** Nine teams will be invited by the Hong Kong Basketball Association to take part in this Championship, namely
- 1) National Basketball Team of India
- 2) National Basketball Team of Malaysia
- 3) National Basketball Team of Thailand
- 4) Southern California Fukienese Association Basketball Team of the USA
- 5) Guangxi WeiZhuang Basketball Club
- 6) National Team of Hong Kong, SCAA
- 7) National Team of Hong Kong, Eastern Long Lions
- 8) National Team of Hong Kong, WinLing
- 9) National Team of Hong Kong, Tycoon
- 3. **PLAYERS:** (a) A maximum of 12 players for each team. (b) Players should hold the passport which is issued by the local government or only one player which hold the resident right certification and issued by local government is allowed. (All registrations must be made on or before 20:00, 29th October, 2018. No change of player is allowed after the deadline.)
- 4. **THE JERSEY:** (a) May carry advertisement and promotional materials (but subject to colour and numbering according to the rules of the game). (b) Each team must possess two (2) sets of shirts, the first named team in the programme shall wear light-coloured shirts (preferably white), the second named team in the programme shall wear dark-coloured shirt.
- 5. **THE SYSTEM OF COMPETITION:** The current FIBA Rules and Regulations (2018 Edition) will be adopted. The following system just serves as a master system of competition. It may be changed upon proposal by the organizers and approval of the Executive Committee of the Hong Kong Basketball Association.

Preliminary Round

The nine (9) participating teams will be divided into three (3) groups (A, B, C) of three (3) teams each. Each team will play with all the other teams in its own group. The 1st in its own group and the best result of the 2nd team of the three groups will qualify for the Semi-Finals which shall be decided by the goal difference, taking into account all the games played in the group. If this criteria cannot decide, a draw shall decide on the classification.

The final standings will be established after the Preliminary Round.

Classification Round

The two teams placed 3rd in the Preliminary Round with the lower total goal difference will be qualified for the Classification Round for 7th, 8th, 9th place.

Game 10: 3rd placed in Preliminary Round vs 3rd placed in Preliminary Round

The teams placed 3rd in the Preliminary Round with the highest total goal difference and the winner of game #10 will be qualified for the Classification Round for 7th, 8th place.

Game 14: 3rd placed in Preliminary Round vs Winner 10

Two teams placed 2nd in the Preliminary Round which cannot enter the Semi-Finals Round will be qualified for the Classification Round for 5th, 6th place.

Game 11: 2nd placed in Preliminary Round vs 2nd placed in Preliminary Round

Semi-Finals Round

The 4 best-placed teams in the Preliminary Round will be qualified for the Semi-Finals.

Game 12: Official Luncheon Drawing A vs Official Luncheon Drawing B

Game 13: Official Luncheon Drawing C vs Official Luncheon Drawing D

Finals Round

The winner of the Semi-Finals Round will be qualified for 1st place. The loser of the Semi-Finals Round will be qualified for 3rd place.

Game 15: Loser 12 vs Loser 13 Game 16: Winner 12 vs Winner 13

Accountant Mr. Lo Ping 稽核: 盧 平先生 6. **SCORING:** For the Single Round-Robin Competition (a) The calculation of points will be as follows: Match won: 2 points Match lost: 1 point Lost by forfeit: 0 point (b) If two teams have the same points, the deciding factor shall be the result of game played between them. (c) If more than two teams tie on points, classifications shall be made by total goal difference, taking into account only the games played between the teams in question (total difference of point scored by each of the tying teams and points scored against them by their opponents). If the goal difference is the same, the team that scores more points will be ranked higher. If this criteria cannot decide, a draw shall decide on the classification.

7. DATE OF TOURNAMENT: December 11 – December 16, 2018

- 8. **PROGRAMMES CHANGE:** There will be no change in the program once it is being announced (unless under indefensible issues such as typhoons, riots and special reasons from the Association).
- 9. **PROTEST:** The referee may decide all issues in dispute during a match. Should there be a protest, the captain of the team in question shall, at the end of the game, sign in the score sheet his name in the area of "protest". In order to make this declaration valid, the leader of the team in question shall within two hours following the end of the game, give confirmation of this protest in writing. A special committee which comprises of experienced basketball personnel will then make the final decision.
- 10. **MISCELLANEOUS:** All issues not mentioned above will be taken care individually by the Organizing Committee. The Organizing Committee reserves the right to amend the Rules and Regulations if it was deemed expedient and necessary.

11. FOR FOREIGN PARTICIPATING TEAMS:

EXPENSES: (a) Each foreign participating team should cover their round-trip travel fare to and from Hong Kong.

- (b) The Organizing Committee will bear the expenses for board and lodging as well as ground transportation for the official delegation of 17 members (one of 17 members should a FIBA Active referee) during two days before (December 9) and one day after (December 17) the Championship.
- (c) For any extra members other than 17 persons, early arrival, and delayed departure, each person concerned must pay his own staying expenses.
